### **Opening Exercises**

  - a. The purchase and sale agreement was executed by the Chair with authorization from the governing board. The purchase price represents a fair market value transaction.
  - b. The appraisal received from the contracted appraiser supports the purchase price and pending transaction.
  - c. Mr. Strader provided a status report on required due diligence for the pending municipal bond financed purchase and sale of the school. The due diligence requirements are being completed as required in the necessary time-frames.
  - d. Mr. Strader distributed and discussed the revised debt service vs. lease comparison provided by the underwriter for the transaction that showed several possible scenarios based on estimates of interest rates.
  - e. Mr. Strader presented the BMO Engagement Letter for authorization by the governing board and execution by the board chairman for BMO's representation as bond counsel for the pending municipal bond financed transaction.

f. Mr. Strader advised the board regarding the date and location of the final Pinellas County EFA Meeting (11/15/18; 4:00 p.m.).
