Opening Exercises

Prior to the opening of the meeting, second grade students from PAMS made a presentation to the Board using Nintendo Labo. Ms. Mary Sill, second grade teacher, was one of 100 teachers selected nationwide by Nintendo to receive Labo materials. Students exhibited how they interact and utilize the LABO system to enhance their classroom studies with technology. Also, sixth grade students who participated in and won the Regional Future Cities competition presented their "city" and made an oral report to members of the governing board. Students presented "Valhalla LORE", their Future Cities competition entry, which they will bring with them to represent PAMS in the International Future Cities competition in Washington DC.

Counsel recommended the parent representative term limit in the bylaws be amended at the board's discretion to allow for the continuance of Mr. Undestad's participation on the governing board.

4. Mr. Strader distributed the FY18-19 Budget Revision. The revision reflected the school's operating experience for the first half of the year and was updated to reflect the results of the bond transaction.
