# **Opening Exercises**

Meeting called to order at 5:15 pm by Jeff Undestad (Ms. Rogers arrived later)

Mr. Dolan motioned to approve the minutes and Mr. Undestad seconded the motion. All were in favor and the motion was passed.

Mr. Undestad asked if any person present would like to speak under the Public Comments section of the agenda. No members of the public requested to speak.

# Principal's Report

Mrs. Linda Schwerer stated her enrollment was 665 with over 450 recommits and 284 new applicants.

Ms. Schwerer introduced Dr. Cherry Hatch as a new member of the administrative team.

Ms. Schwerer distributed a copy of her "Captain's Report" and proceeded to describe many exciting and captivating activities at PAMS including, Discovery Nights; FSA Parent Information Night; Parent Conference Week; Honor Roll Assemblies; Winter Program; Daddy Daughter Dance; Future Cities (PAMS took 1<sup>st</sup> Place in the Technical Essay category); Science Olympiad (PAMS took 3<sup>rd</sup> Place in Anatomy & Physiology Category); USF Engineering Expo for PAMS' Gifted classes; Stepping up into STEAM night; FUN Run (March); AdvancEd accreditation renewal visit (March 7); and Robo Fest scheduled the end of March.

Ms. Schwerer reported that a former PAMS students was the Valedictorian at LARGO HS IB Program.

Ms. Schwerer also described a very popular activity where students "moved-up" to meet their teacher, etc. for the 2018-2019 school year.

## **Information Items**

Mr. Strader discussed the following items.

- <u>Monthly Financial Report</u> Mr. Michael Strader, President of Charter School Associates provided an overview of the monthly financial report and informed the Board of the details that are included in their board packet.
- <u>Charter Application Update</u> Mr. Strader distributed a copy (printed) of the St. Petersburg
  Academy of Math and Science charter application as revised and submitted to the School
  Board of Pinellas County on February 1. Mr. Strader indicated that Mr. Rick Wolfe had
  contacted him to say the District would be in contact to schedule an interview following
  the District's review of the revised application.
- <u>Capital Outlay Funds</u> Mr. Strader reported that the District paid capital outlay funds to PAMS with a letter indicating the outcome of the lawsuit by Pinellas County School Board (and other Florida school districts) might result in a "claw back" of the funds that came from the District's ad valorem portion. A copy of the District letter was distributed to board members.
